**ORDER:**

Funds for various ongoing schemes and new schemes have been included in PIP 2012-13 and approved by NPCC vide reference 2<sup>nd</sup> cited and also by 19<sup>th</sup> Executive Committee meeting. The scheme for hiring of private specialist for rendering MCH care, incentives for EmOC and LSAS trained doctors and Government specialist for MCH services had been included in PIP 2012-13.

Provision of incentives for EmOC and LSAS trained doctors had been approved by NPCC vide reference 2<sup>nd</sup> and 19<sup>th</sup> Executive Committee meeting vide reference 3<sup>rd</sup> cited above. The scheme for hiring private specialists had been approved vide reference 4<sup>th</sup> cited above in the reference 5<sup>th</sup> cited above, Deputy Director of Health Services had requested for funds of Rs. 30 lakhs towards hiring of private specialists to meet out backlog payments and also for 2012-13. Considering the request of the Deputy Director of Health Services it is decided to release the funds to the Deputy Director of Health Services, Vellore.

Sanction is hereby accorded for the drawl and disbursement of Rs.30 lakhs (Rupees thirty lakhs only) towards hiring of private specialist to Deputy Director of Health Services, Vellore.

The Financial Advisor and Chief Accounts Officer, State Health Society, Chennai – 6 is hereby authorised to draw the sanctioned amount of Rs.30 lakhs (Rupees thirty lakhs only) from ICICI accounts and release the funds to the District Health Society, Vellore by means of e-transfer. The expenditure is debitible to A.8.1.8.5.

The Deputy Director of Health Services of the district Vellore is requested to release the funds to the implementing institution and follow the guidelines mentioned in the annexure and monitor the implementation of the scheme. The Deputy Director of Health Services are also requested to send consolidated Utilisation Certificate and statement of

expenditure every month without fail along with institution wise list of cases for which the private / Government specialist / trained doctors were hired for MCH care.
