ORDER:

Under strengthening of FRUs in the year 2010-11 and 2011-12, a sum of Rs.290.00 lakhs had been released for construction of Out Patient Block, ward and operation theatre to Government Hospital, Chidambaram in Cuddalore district, in the references 2nd and 3rd cited.

In the reference 4th cited, a sum of Rs.6.20 lakhs (Rupees Six lakhs and twenty thousand only) is required for the additional works and alternation now to be carried out to the OP block and OT in Government Hospital, Chidambaram which are required for normal functioning of the institution.

Considering the necessity, it is decided to provide the additional funds of Rs.6.20 lakhs to Government Hospital, Chidambaram, Cuddalore District.

Therefore sanction is hereby accorded for the drawal and release of Rs.6.20 lakhs (Rupees Six lakhs and twenty thousand only) to the District Health Society, Cuddalore, towards the provision of additional funds for the Government Hospital, Chidambaram.

The Financial Adviser and Chief Accounts Officer, SHS, Chennai-6 is hereby authorized to draw the funds of Rs.6.20 lakhs (Rupees Six lakhs and twenty thousand only) from SHS funds in ICICI Bank and to release to the District Health Society, Cuddalore by means of e-transfer / RTGS.

The Executive Secretary, District Health Society, Cuddalore is hereby requested to release the funds to the concerned PWD authorities by means of cheque.

The Executive Secretary, District Health Society, Cuddalore is requested to send Utilisation Certificate / Statement of Expenditure for the funds released in this regard.
