**Order:**

Proposal for various ongoing programmes are included in PIP: 2012-13 and was approved by Government of India/NPCC-vide reference 2<sup>nd</sup> cited. The same was also approved by Executive Meeting in the 19<sup>th</sup> meeting held on 14.6.12. One among the proposal is salary to Staff Nurses in 24x7 delivery care centres staff Nurses etc in MMU's. In the reference 4<sup>th</sup> cited salary for April 12 to September 12 was released. Now, it is proposed to release funds for October 12 to March 13, for the above purpose.

In the persuance of the reference cited, Sanction is hereby accorded for the drawal and disbursement of a sum of Rs.1950.87 lakh (Rupees nineteen crores fifty lakhs and eighty seven thousand only) towards the payment of salary to staff as detailed in Annexure-II.
