## **ORDER:**

Reduction of MMR is one of the MDG and also goal of NRHM. Maternal Death Audits indicate that more than fifty percent of mothers, who lost their lives in the process of giving lives, had one or more complications during the pregnancy. Mobilizing and admitting the women with risk factors in a functional CEmONC centre well before the EDD will be an effective strategy to provide quality EmONC services to such mothers in time.

Due to lack of space in District Headquarters Hospitals and Medical College Hospitals all these women could not be admitted for a week's time. If such women are identified in time and admitted in CHCs, proper monitoring of vital parameters can be done effectively. Guidelines for monitoring theses High Risk Mothers will be communicated shortly.

A estimated 15% of mothers are likely to have one or others types of complications. Hence, it is proposed to admit the High risk Mothers for observations in UG PHCs and Level-II MCH Centres given in the Annexure-III. The high risk mothers shall be admitted in these centres along with an attender and they will be shifted to the CEmONC center in time with the help of 108 ambulance of PHC ambulances. The mothers requiring referral to higher centre shall be accompanied by a Staff nurse or ANM and the staff nurse/ANM will be paid an amount of Rs.100 per case.

During the period of stay of the HRM mothers in the facility, an attender will be permitted to stay with the patients and dietary charges for the parents and attender will be incurred at Rs.80/day/person. The dietary guidelines communicated for the feeding and dietary charges of PN/post-LSCS mothers will be adhered to the HRM mothers also, however the cases like of GDM, Heart Diseases etc will provided diet with modifications as the case warrants.

The dietary charges has been released for an approximate period of 10days per case however the HR mothers will be provided diet along with the attender for the whole period of stay in the facility based on the merit of the case. The above proposals has been included in PIP 2012-13 and approved by NPCC vide Ref.2 cited and placed before the 20<sup>th</sup> Executive Committee on 01.08.2012 and approved by the same vide Ref.3cited.

Sanction is hereby accorded for the drawal and disbursement of Rs.425 lakhs(Rupees Four Hundred and Twenty Five lakhs only) towards provision of diet to HRM in UG PHCs and Level-II MCH centres and incidental expenses to Staff Nurses or ANM for accompanying the mothers to the CEmONC centres. The HUD wise break up for release of funds is given in Annexure-I.

The Financial Advisor and Chief Accounts Officer, State Health Society, Chennai – 6 is hereby authorised to draw the above sanctioned amount of Rs.425 lakhs(Rupees Four Hundred and Twenty Five lakhs only)from RCH/NRHM funds and disburse the same to DHS as detailed in Annexure-II. The expenditure is debitable to B.14.1-Funds to dietary charges to HRM with attender and B.14.2-Incidental Expenses to S/N and ANM.
