**ORDER:**

Proposals for various organizing and new proposals are included in PIP:2012-13 and was approved by GOI/NPCC-vide reference 2<sup>nd</sup>& 3<sup>rd</sup> cited. The scheme was also approved by EC-vide reference 4<sup>t</sup> & 5<sup>th</sup> cited. One among the proposals is hiring of private Specialist for rendering MCH care, incentives for EmONC& LSAS. Trained doctors & Government Specialist for MCH services. In the reference 6<sup>th</sup> cited, the DDHS, Kancheepuram requested for the release of Rs.14lakhs to incur expenditure on hiring of Obstetricians and Anesthetist for MCH camp and it is decided to release the funds.

Sanction is hereby accorded for the drawl and disbursement of a sum of Rs.14 lakhs (Rupees Fourteen lakhs only) towards hiring of Obstetricians and Anaesthetist to Deputy Director of Health Services, Kancheepuram.

The Financial Advisor and Chief Accounts Officer, State Health Society, Chennai – 6 is hereby authorised to draw the sanctioned amount of Rs.14 lakhs (Rupees fourteen lakhs only) from NRHM/RCHP and disburse the same to DDHS, Kancheepuram by e-transfer.

The expenditure may be debited under the head of Account” RCHP-A.8.1.8.5-Hiring of Anaesthetist”.

The Deputy Director of Health Services, Kancheepuram is requested to release the funds to the implementing institutions duly following the enclosed guidelines. The Deputy Director of Health Services is requested to furnish consolidated Utilisation Certificate and statement of expenditure every month without fail along with institution wise list of cases for which the private / Government specialist / trained doctors were hired for MCH care.
