ORDER:

In the Government Order first read above, orders have been issued that the fund approved by Government of India for Civil works under Reproductive Child Health /National Rural Health Mission has to be remitted into Government account under receipt head and orders have to be obtained from Government of Tamil Nadu for the release of funds to Public Works Department for execution of the works.

- 2. In the Government Order second read above, administrative sanction was accorded to strengthen the maternity wings at District Hospitals at Cuddalore and Tiruppur at a total cost of Rs. 4000/- lakh (Rs. 3600 lakh for civil work and Rs. 400 lakh for furniture and Equipments) A sum of Rs. 1200/- lakh was also sanctioned to carryout the civil works for the above two hospitals through Public Works Department.
- 3. In the Government order third read above, a sum of Rs. 1000 lakh for civil work for strengthening the Maternity and Child Health wings and District Head Quarters Hospitals at Cuddalore and Tiruppur, was sanctioned.
- 4. The Mission Director, National Health Mission has stated that in respect of the balance funds required for the civil works, a detailed proposal had been included in Sup. Programme Implementation Plan (PIP) 2017-18 and the proposal was

approved in Sup Record of Proceedings 2017-18. Hence, the funds of Rs.1400 lakh (as last installment) is remitted into Government account, as detailed below, vide Challan No. 041, dated 05.03.2018 of State Bank of India, Treasury Branch, Thousand Light, Chennai – 06.

- 6. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and issue the following orders accordingly:
 - (i) Financial sanction is accorded for a sum of Rs. 1400 lakh (Rupees one thousand four hundred lakh only) for civil works through Public Works Department, for strengthening of Maternity Child Health Wing in Government Head Quarters Hospitals at Cuddalore and Tiruppur as detailed below:-

- 8. With the reference to civil works, the amount sanctioned in para 6 (i) above shall be debited to the following Head of Account:-
