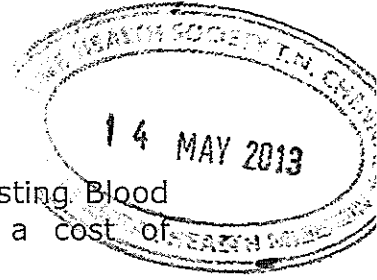

ABSTRACT

NRHM - State Health Society, Tamilnadu – Upgradation of existing Blood Storage Centre at Government Hospital, Thiruchendur at a cost of Rs.25 lakh – Orders – Issued.

ORDER:

The Mission Director, State Health Society in his letter read above that the Government Hospital, Tiruchendur is a delivery point and catering to a large floating population. The nearest blood bank is 40 km. away at Thoothukudi Medical College Hospital. Hence, it is proposed to upgrade the Blood Storage Centre at Government Hospital, Tiruchendur at a cost of Rs.25 lakhs. A proposal to this effect was included in PIP 2012-13 and approved by Government of India. The same was also approved by Executive Committee in the 19th meeting held on 14.6.12. As per G.O.Ms.No.116, H&FW Dept., dated .25.3.11, a sum of Rs.25 lakhs was drawn from NRHM funds and remitted to Government account vide chalan No.9502, dated .26.11.12 at State Bank of India, Thousand Lights Treasury Branch, Chennai under the head of account "0210-Medical and PH-02-RHS – 800 other receipts – AD receipts from GOI for NRHM works" (DP code No.0210-02-800-AD-0002).

2) The Mission Director, State Health Society has requested the Government that a sum of Rs.25 lakh (Rupees Twenty five lakh only) may be sanctioned to PWD authorities, for the construction of Blood Storage Centre at Government Hospital, Tiruchendur. The Engineer in Chief and Chief Engineer (Buildings), PWD, Chepauk, Chennai may be authorized to issue orders to the Executive Engineer of PWD concerned for drawing the funds thro' Pay and Accounts Officer / Treasury as the case may be, for the construction of new Blood Storage Centre at Government Hospital, Tiruchendur under the head of account "4211-00 Capital Outlay on FW 103 – Maternity and Child Health Schemes shared between Central and State". He has also requested the Government to make necessary provisions in the FMA 2012-13 under the capital outlay "4211-00-103-16 minor civil works for 1909 RCH Department and to authorize to draw the funds pending provision of funds in the FMA 2012-13.

3) In G.O.Ms.No.116, Health and Family Welfare Department, dated 25.3.2011, the provision of execution of civil works utilizing the National Rural Health Mission funds through the Public Works Department was streamlined and it was directed that all the funds received for civil

works under National Rural Health Mission be remitted to State Government receipts account. The Mission Director, State Health Society was directed to remit the Government of India funds as and when received under National Rural Health Mission and send separate proposal to Government for getting the amount sanctioned from the consolidated fund of the State Government by opening a new capital sub head of account under "4211-00-Capital outlay on Family Welfare - 103 maternity and child health - schemes shared between centre and state". As per the above order, the Mission Director, State Health Society has remitted a sum of Rs.25 lakh to Government receipt head for the construction of Blood Storage Centre at the Government Hospital, Thiruchendur.

4) The Government after consideration has decided to accept the proposal of the Mission Director, State Health Society. They accordingly sanction a sum of Rs.25 lakh (Rupees twenty five lakh only) to the Chief Engineer (Building), Public Works Department for the construction of new Blood Storage Centre at Government Hospital, Thiruchendur as requested by the Mission Director, State Health Society.

5) The expenditure sanctioned in para 4 above shall be debited to the following head of account:

"4211-00-Capital outlay on Family Welfare - 103 maternity and child health - schemes shared between Centre and State-III Centrally Sponsored - SA. National Component - Reproductive and Child Health Project -16.Major Works (DPC 4211 00 103 SA 1608)

6) This order issues with the concurrence of the Finance department vide its U.O. No.61/J.S/(Dr.PU)/Health-I/2013 dated 1.4.2013.


