ORDER:

- State Health Society, has stated that the Apex . The Mission Director, Committee of National e-Governance Plan (NeGP) headed by the Cabinet Secretary has included Mother and Child Tracking System of Department of Health and Family Welfare Department as a Mission Mode Project under NeGP. A Central Project e-Mission Team has been constituted at the Central level to provide overall guidance and closely monitor implementation of the project at the national level. As the project is being implemented by States / UTs it is necessary to put in place institutional structures to monitor, guide and drive the project at the State and District level. As per the direction of the Ministry of Health and Family Welfare, it is proposed to constitute State Project e-Mission Team and District Project e-Mission Teams in Tamil Nadu. Directorate of Public Health and Preventive Medicine is implementing PICME, a project for Mother and Child Tracking System in Tamil Nadu to closely monitor the essential services delivery to the pregnant mother and infants upto 1 year of age. As PICME the On-Line Software, is implemented in Tamil Nadu and considering the importance of the services, it felt that the co-ordination and inputs of line departments and monitoring at State and District level would strengthen it.
- 2. The Mission Director, State Health Society in his letter read above has proposed the formation of State e-Mission Team under the Chairmanship of Secretary to Government, Health and Family Welfare Department and the District e-Mission Team under the Chairmanship of District Collector with other Members as per the guidelines of the Government of India.
- 3. The Government have examined the proposal of the Mission Director, State Health Society carefully in detail and decided to accept the proposal with some modifications. The Government direct that the State e-Mission Team and District e-

mission team be constituted with the following members to provide overall guidance and to closely monitor the implementation of the Mother and Child Tacking System
