ORDER:

Hon'ble Minister (Health and Family Welfare) among other has made an announcement in the Tamil Nadu Legislative Assembly on that "31 Data Entry Operators and 31 Accounts Assistants will be appointed in all offices of the Joint Director of Medical and Rural Health Services and **32 Physiotherapists in District Headquarters Hospitals will be appointed on consolidation pay**"

2. The Mission Director, State Health Society has stated that provision for one post of Physiotherapist, each for 32 Districts in Head Quarters Hospitals is one of the approved activities under National Program for prevention and control of Cancer, Diabetes, CVDs and Stroke (NPCDCS). The proposed activity is sanctioned for 32 Districts. This includes one each for 31 District Head Quarter hospitals at Ariyalur, Coimbatore, Cuddalore, Dharmapuri, Dindugal, Kancheepuram, Madurai, Erode, Krishnagiri, Kanyakumari, Karur, Nagapattinam, Namakkal, Nilgris, Salem, Sivagangai, Perambalur, Pudukottai, Ramanathapuram, Tiruppur, Thanjavur, Trichy, Tiruvallur, Thiruvannamalai, Thoothukudi, Tirunelveli, Theni, Villupuram, Vellore & Virudhunagar. In the case of Chennai one physiotherapist is proposed for the Institute of Non-communicable diseases, Government Royapettah Hospital.

3. In the Record of Proceedings 2017-18, 32 posts of Physiotherapist have been approved at the rate of Rs.25,000/- p.m for providing services at the District Head Quarters Hospitals.

4. The Mission Director, State Health Society has requested the Government Orders in this regard.

5. The Government after careful consideration to accept the proposal of Mission Director, National Health Mission and accordingly issue the following orders:-

- (i) The Mission Director, National Health Mission is permitted to establish Rehabilitation wing in 32 Districts comprising of Geriatric, Palliative, Stroke, Non Communicable Disease wing, in 31 District Headquarters Hospitals except Chennai and in respect of Chennai at the Institute of Non Communicable Disease in Government Royapettah Hospital.

- (ii) The Mission Director, National Health Mission is permitted to place 32 Physiotherapist posts one each for 32 Districts listed in the Annexure to this order through outsourcing with the following eligible criteria.

- (iii) The Mission Director, National Health Mission is directed to ensure that the Outsourcing Agency which engages the service of the employee shall stipulate the condition in its agreement that eliminates the consequential claim chances for future absorption into regular service at any cost.
- (iv) The Mission Director, National Health Mission is directed to stipulate the condition in its agreement with the outsourcing agency that eliminates the consequential claim chances for future absorption into regular service at any cost.
