ORDER:

In the Government Order first read above, sanction has been accorded for implementation of District Mental Health Programme in 9 districts namely Villupuram, Pudukottai, Tiruppur, Sivagangai, Thoothukudi, Karur, Dindigul, Thiruvannamalai and Tirunelveli at the total cost of Rs.433.08 lakh for 2014-2015 and 2015-2016. Out of this total cost, an amount of Rs.13.42 lakh has been provided and released during the year 2014-2015.

- 2. The Director of Medical and Rural Health Services has requested to release the remaining amount of Rs. 419.66 lakh earmarked for the year 2015-16 for further implementation of the programme in 9 districts.
- 3 The Government have examined the proposal of the Director of Medical and Rural Health Services and has decided to release the amount of Rs. 419.66 lakh (Rupees four hundred and nineteen lakh and sixty six thousand only) for implementation of District Mental Health Programme in Nine (9) Districts viz. Villupuram, Pudukottai, Tiruppur, Sivagangai, Thoothukudi, Karur, Dindigul, Thiruvannamlai and Tirunelveli for the year 2015-16.

The Director of Medical and Rural Health Service is directed to include this expenditure while sending proposal for Revised Estimate / Final Modified Appropriation/ Supplementary Estimates to Government in Finance Department without fail.
