



## **ABSTRACT**

### **ORDER:**

In the letter second read above, the Mission Director, State Health Society has stated that as per Indian Nursing Council norms, additional buildings such as quarters for examiners / faculty members and Hostel rooms are required for the existing 9 Auxiliary Nurse Midwifery (ANM) Schools detailed below. Therefore, a detailed proposal has been included in Programme Implementation Plan 2017-2018, for providing additional buildings to the existing ANM Schools at a total cost of Rs. 625 lakh. The proposal is approved by the National Program Coordination Committee (NPCC) of Government of India, with the budgetary provision of Rs. 312.48 lakh only for the year 2017-2018.

2. The Mission Director, State Health Society has stated that a sum of Rs.312.48 lakhs (Rupees three crore twelve lakh and forty eight thousand only) being the fund approved for the year 2017-2018 for the civil works detailed has been remitted to Government of Tamil Nadu account as per the procedure laid down vide Government Order first read.

3. The Mission Director, State Health Society has requested the Government Order in this regard. The above proposal was approved by 33<sup>rd</sup> Executive Committee Meeting.

4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and issue the following orders:

- i. Administrative Sanction is accorded for the construction of additional building for 9 existing Auxiliary Nurse Midwifery (ANM) schools at a total cost of 625 lakhs (Rupees six crore twenty five lakh only).

- ii. Sanction is accorded for a sum of Rs.312 lakh (Rupees three crore twelve lakh only) for construction of additional building for 9 existing Auxiliary Nurse Midwifery (ANM)schools through Public Works Department.
- iii. The Engineer in Chief and Chief Engineer buildings Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.
- iv. The Mission Director is permitted to remit the balance of funds required for the civil works as and when it is approved by Government of India in to the following Head of account:-

"0210 – Medical and Public Health 02 – Rural Health Services 800 – Other Receipts AD – Receipt from Government of India for National Rural Health Mission"

5. The expenditure sanctioned in para 4(ii) above shall be debited into the following Head of Account:

"4211-00 Capital outlay on Family Welfare – 103 – Maternity and Child Health – Central sector schemes – SA National component – Reproductive and Child Health Project – 16 Major works"
