**ORDER:**

The Mission Director, State Health Society in his letter read above has stated that College of Nursing, Madras Medical College, Chennai has been identified to function as a National Nodal Centre for Pre – Service Education in Nursing in Tamil Nadu by the Ministry of Health and Family Welfare, Government of India with technical support from JHPIEGO, an international technical support agency to National Health Mission. This National Nodal Centre will facilitate in improving the quality of Pre Service Education in Nursing Midwifery Cadre among ANM/GNM School faculties in the State of Tamil Nadu as well as in the States of Karnataka, Andhrapradesh, Telengana and Kerala.

2. The Mission Director, State Health Society has also stated that JHPIEGO has been identified as the technical support agency for the Pre-Service Education (PSE) strengthening initiative by the Ministry of Health and Family Welfare, and it would be supporting establishment and operationalization of five National Nodal Centres across the country with Department for International Development (DFID) support. JHPIEGO will also provide continuous technical support for strengthening the College of Nursing, Madras Medical College, Chennai through development of an action plan to address the gaps and support implementation of the planned activities to achieve 70-80% of the Indian Nursing Council endorsed performance standards. For National Nodal Centre Chennai, the cost of

equipment, mannequins and models for Skills lab, Library books and Information Technology lab equipment would be directly borne by JHPIEGO with Department for International Development (DFID) support. The breakup details of the following activities proposed for National Nodal Centre, Chennai with total budget at a cost of Rs. 75.015 lakh, out of which the National Health Mission funding for the period upto March 2017 will be Rs.62.445 lakh.

JHPIEGO will also be supporting the salary of the Human Resource of National Nodal Centre, Chennai from August 2015-March 2017. Two Nursing Midwifery Tutors (NMTs) and one Program Coordinator (PC) would be recruited at the College of Nursing, Madras Medical College, Chennai. JHPIEGO will also bear the cost of mentorship and follow up visits undertaken by these Nursing Midwifery Tutors till March 2017.

3. He has further informed that till March 2017, the following budget will be borne by JHPIEGO through National Health Mission Programme Implementation Plan (PIP) and beyond 2017, the State is expected to bear this cost towards conduct of the training.

The Mission Director, State Health Society has requested the Government orders for the commitment of Rs.28.50 Lakh (Rupees twenty eight lakh fifty thousand only) beyond National Health Mission period i.e., March 2017 by the State Government towards the conduct of the training for ANM/GNM School faculties at the National Nodal Center, College of Nursing, Madras Medical College, Chennai and salary for two Nursing Midwifery Tutors and one Programme Co-ordinator as mentioned above and also requested permission to sign Memorandum of Understanding (MoU) with JHPIEGO/ Government of India by him.

5. The Government have examined the proposal of Mission Director, State Health Society, Tamil Nadu carefully and decided to approve the proposal as below:

- i. The Mission Director, State Health Society is permitted to sign Memorandum of Understanding (MoU) with JHPIEGO in anticipation of approval of Programme Implementation Plan (PIP), National Health Mission & Executive Committee of State Health Society and in anticipation of clearance of Budget Proposal sent to Director of Medical Education. ( for Rs.12.57 lakh).
- ii. The Mission Director, State Health Society is directed to take necessary action to take necessary action to send relevant proposal for inclusion in the supplementary PIP 2015-16 for approval and to subsequently place before the Executive Committee for approval without fail.
- iii. The Mission Director, State Health Society, Tamil Nadu is also directed that the proposal for sanction of funds beyond National Health Mission period i.e., after March 2017 may be sent to Government for consideration at the time of completion of National Health Mission Programme in the State.

6. This order issues with the concurrence of the Finance Department vide its U.O.No. 63818/Health-I/2015, dated: 14.12.2015.
