### **ABSTRACT**

#### ORDER:

In Government order 1<sup>st</sup> read above, among others, Government have issued orders for establishment of Primary Health Centre at Vanavasi, Salem District in 2008-2009 under National Health Mission with a fund provision of Rs.21.792 lakh for construction of building.

- 2. In Government order 2<sup>nd</sup> read above, among others, Government have issued orders for establishment of Primary Health Centres at Samayapuram, Trichy District and Konavattam, Vellore District under National Health Mission with a fund provision of Rs.22.00 lakh per Primary Health Centre for construction of buildings. Subsequently, in Government order 3<sup>rd</sup> read above, among others, additional fund of Rs.9.50 lakh has been sanctioned to Samayapuram Primary Health Centre, Trichy District.
- 3. The Mission Director, State Health Society in his letter 4<sup>th</sup> read above has stated that the construction of new building to Vanavasi Primary Health Centre, Salem District as ordered in Government order 1<sup>st</sup> read could not be taken up, as suitable site was not identified. The fund provided for Primary Health Centre Vanavasi, Salem District had been diverted to Primary Health Centre Sathanur Dam, Tiruvannamalai District. He has also stated that now the required site for construction of new buildings to the Primary Health Centre, Vanavasi, Salem District has been identified and allocated.
- 4. The Mission Director, National Health Mission has also stated that it has been decided to execute the construction of new buildings to Primary Health Centre Vanavasi, Salem District at revised administrative cost of Rs.53.50 lakh (Rupees Fifty three lakh and fifty thousand only) and to provide the required fund from the unspent amount of Primary Health Centres Konavattam, Vellore District and

Samayapuram, Trichy District as the suitable site was not identified, for these two Primary Health Centres as ordered in Government order 2<sup>nd</sup> and 3<sup>rd</sup> read.

- 5. The Mission Director, National Health Mission has also stated that in anticipation of Government orders, the Public Works Department has been authorized to execute the construction of new buildings to Primary Health Centre Vanavasi, Salem District at the revised administrative sanction amount of Rs 53 50 lakh.
- 6. The Mission Director, National Health Mission has also stated that the proposals for ratifying the action of him for having cancelled the works of Primary Health Centres Konavattam, Vellore District and Samayapuram, Trichy District for providing funds to Primary Health Centre Vanavasi, Salem District and for having authorized the Public Works Department to take up the construction of building to Primary Health Centre Vanavasi, Salem District at the revised administrative sanction amount of Rs.53.50 lakh were placed in the 30<sup>th</sup> Executive Committee held on 14.07.2016 and the same has been approved.
- 7. The Mission Director, National Health Mission has therefore requested the Government orders in this regard.
- 8. After careful examination the Government have decided to accept the proposal of Mission Director, National Health Mission and accordingly issue the following orders:
  - i) Permission is accorded to Mission Director, State Health Society to execute the civil works of Primary Health Centre Vanavasi, Salem District through Public Works Department at the revised administrative sanction amount of Rs.53,50,000/- (Rupees Fifty three lakh and fifty thousand only).
  - ii) The action of Mission Director, State Health Society in having cancelled the works of Primary Health Centres Konavattam, Vellore District and Samayapuram, Trichy District for providing funds to Primary Health Centre Vanavasi, Salem District and in having authorized the Public Works Department to take up the construction of building to Primary Health Centre Vanavasi, Salem District at the revised administrative sanction amount of Rs.53,50,000/- (Rupees Fifty three lakh and fifty thousand only) in anticipation of Government order is ratified.
  - iii) An amount of Rs.53,50,000/- (Rupees Fifty three lakh and fifty thousand only) is sanctioned to carry out the civil works of Primary Health Centre Vanavasi, Salem District through Public Works Department.
  - iv) The Engineer in Chief and Chief Engineer buildings, Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.
- 9. The expenditure sanctioned in para 8(iii) above shall be debited to the following head of account.

"4211-00- Capital outlay on Family Welfare -103-Maternity and Child Health - Central Sector Schemes - SA - National component - Reproductive and Child Health Project - 16 Major works."

Necessary additional funds have been provided in Revised Estimate 2017-18. The Chief Engineer and Engineer in Chief (Buildings) is authorized to draw and disburse the amount sanctioned in para 8(iii) above.
