ORDER:

The Hon'ble Minister (Health and Family welfare) has made an announcement on the floor of Tamil Nadu legislative assembly that Comprehensive Primary Health Care Services which is under implementation in 3 Health Unit Districts namely, Krishnagiri, Pudukkottai and Perambalur, will now be expanded to the rest of 39 Health Unit Districts at a cost of Rs. 24.74 crore.

2. In Government order 1st read above, orders were issued launching the pilot project on Comprehensive Primary Health Care Services in the three blocks namely Krishnagiri – Shoolagiri Block, Pudukottai – Viralimalai Block and Perambalur – Veppur Block and permission was also accorded to utilize a sum of Rs.599.07 lakh (recurring and non-recurring) for the above project.

3. The Mission Director, State Health Society in the letter 2nd read above has stated that the proposal for upscaling the programme of Comprehensive Primary Health Care Services / Universal Health Care in the remaining 39 Health Unit Districts at the rate of one per block per Health Unit Districts with fund provision of Rs.4417.84 lakh was placed in Programme Implementation Plan 2017-18 and a sum of Rs.2474.07 lakh was approved by National Programme of Co-ordination Committee in Record of Proceedings 2017-18.

4. The Mission Director, State Health Society has also stated that the above proposal was placed in the 33rd Executive Committee meeting vide agenda no.18 and the same was approved.

5. The Mission Director, State Health Society has therefore requested Government orders in this regard.

6. After careful examination, Government have decided to accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:-

- i) the Mission Director, State Health Society is permitted for upscaling the programme of Comprehensive Primary Health Care Services / Universal Health Care (UHC) in the following 39 Health Unit Districts (HUD) at one block per Health Unit District under National Health Mission at a total cost of Rs.4417.84 lakh:-
