ORDER:

In the letter first read above the Mission Director, State Health Society has stated that Government of India have issued sanction orders towards the Cost Adjustment of supply of vaccines under Routine Immunization to the value of Rs.8,35,46,000/- in the year 2014-15. The details of sanction orders are as follows:-

The corresponding 25% of the State Share against the 75% of the Government of India release of **Rs. 8,35,46,000/- (Rupees Eight crore thirty five lakh and forty six thousand only)** relating to the year 2014-15 works out to **Rs.2,78,48,667/- (Rupees Two crore seventy eight lakh forty eight thousand six hundred and sixty seven only)**.

3. The Mission Director, National Health Mission as per the clarification issued vide Government of India letter second cited has requested the Government to release a sum **Rs.2,78,48,667/- (Rupees Two crore seventy eight lakh forty eight thousand six hundred and sixty seven only)** towards State Share against the Govt. of India Cost Adjustment of the Vaccines supplies under Routine

Immunization Programme (Reproductive and Child Health) during 2014-15 as mentioned above.

4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum **Rs.2,78,48,667/- (Rupees Two crore seventy eight lakh forty eight thousand six hundred and sixty seven only)** towards State Share against the Government of India Cost Adjustment of the Vaccines supplies under Routine Immunization Programme (Reproductive and Child Health) for the year 2014-15.
