ORDER:

The Director of Family Welfare in his letter third read above, has stated that the Government had already granted permission to the Director of Family Welfare to pay a sum of Rs.150/- per case as incentive to the service provider / Anganwadi worker for the Post-Partum Intra Uterine Contraceptive Device (PPIUCD) insertion based on the guidelines of the Government of India. The fund for this scheme is being allotted by the Government of India in the Programme Implementation Plan and released by the Mission Director, State Health Society, Chennai-6. The Government of India in its letter second read above has issued guidelines and issued orders to pay a sum of Rs.300/- to the PPIUCD acceptors after the insertion to cover their incidental and travel cost to enable them to come for follow up in addition to the existing PPIUCD incentive package of Rs.150/- each to Accredited Social Health Activities (ASHA) and provider. Based on the revised guidelines of Government of India, a revised sanction order is necessary with permission to pay Rs.300/- to the PPIUCD acceptors with effect from 01.04.2017. He has also stated that the Government of India has approved Rs.1125.00 lakh under National Health Mission Tamil Nadu State, Programme Implementation Plan for the year 2017-2018 towards 2.50 lakh of PPIUCD insertions at Rs.150/- per case as incentive for service provider and Rs.300/- per case as beneficiary compensation.

2. The Director of Family Welfare has requested the Government to issue revised sanction order permitting the Director of Family Welfare to implement the scheme of revision of beneficiary compensation for PPIUCD insertion as Rs.300/- per case with effect

from 01.04.2017 in addition to the payment of Rs.150/- per case as incentive to the service providers for PPIUCD insertion.

3. The Government after careful examination has decided to accept the above proposal and accordingly grant permission to the Director of Family Welfare to pay Rs.300/- as beneficiary compensation to the PPIUCD acceptors with effect from 01.04.2017 as per Government of India guidelines in addition to the payment of Rs.150/- per case as incentive to the service providers for PPIUCD insertions. He is also permitted to utilize the funds released by the Mission Director, State Health Society for the year 2017 – 2018 as approved by Government of India in the Programme Implementation Plan for 2017 – 2018.
