ORDER:

The Mission Director, State Health Society in the letter 12th read above has stated that the National Rural Health Mission is funding to establish new Primary Health Centres and to upgrade the existing Primary Health Centres in rural areas in order to deliver Health service to the rural public and to improve the existing services. The National Rural Health Mission is also funding for construction of new buildings to new Primary Health Centres and to upgrade Primary Health Centres and for providing additional facilities to Primary Health Centres and Government Hospitals in the State.

2. The Mission Director, National Health Mission has also stated that due to the following reasons various civil works are pending, till now:-

- i) delay in finalization of sites
- ii) soil conditions of the sites
- iii) filling the low lying areas
- iv) structures in Hilly areas
- v) revision of schedule of rates in every year

3. Additional funds are required to complete the pending 62 civil works. The details are as follows:-

4. The Mission Director, State Health Society has also stated that to bring the utilization of above pending 62 civil works, a detailed proposal was included in PIP 2016-17 with additional fund provision of Rs.1373.93 lakh. But, the same has not been approved by Government of India.

5. The Mission Director, State Health Society has also stated that every year, the Government of India approves the administrative sanction to the tune of Rs.220.98 crore which has been credited into State Government account and utilized by the Directorate of Family Welfare through State Budget, for infrastructure maintenance. Against that allocation, 40% State share has been drawn and credited into State Health Society account to implement the schemes approved under National Health Mission. Further, on submission of Audit Certificate by the Accountant General, the excess amount incurred by the Directorate of Family Welfare has been reimbursed by the Government of India to the State Government by means of Liquidation of arrear. As per instructions of the Government of India, the State share for the liquidation of arrear is also drawn from State Government and credited into State Health Society account and utilized for the schemes under National Health Mission.

6. The Mission Director, State Health Society has also stated that in anticipation of the receipt of State share against the release of liquidation of arrear for Infrastructure Maintenance from Government of India, the amount of Rs.1373.93

lakh required for the pending 62 civil works may be considered to complete the above constructions and to put into use immediately for the poor and needy. In this regard, a detailed proposal has been placed in the 31st Executive Committee meeting vide agenda No.12 and the same was approved.

7. The Mission Director, State Health Society has therefore requested Government order in this regard.

8. The Government, after careful examination, issue the following orders:-

- i) the Mission Director, State Health Society is permitted to utilize the State share of liquidation of arrears for infrastructure maintenance to the tune of Rs. 4,65,25,000/- (Rupees Four crore sixty five lakh twenty five thousand only) to complete the following 23 pending civil works under National Health Mission and revised administrative sanction is ordered as follows:-

10. The Mission Director, State Health Society is also permitted to send the proposals to Government for revision of the cost of civil works, wherever necessary.
