The corresponding 40% of the State share against the 60% of the Government of India share of Rs.55,24,53,000/- (Rupees Fifty Five Crore Twenty Four Lakh and Fifty Three Thousand only) works out to Rs.36,83,02,000/- (Rupees Thirty Six Crore Eighty Three Lakh and Two Thousand Only).

2 The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.39,83,02,000/- (Rupees Thiny Six Grore Eighty Three La II and Two Thousand Only) being the State Share

contribution of Grants-in-Aid to the Third and Fourth Installment Infrastructure Maintenance under National Rural Health Mission for the year 2018 - 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.

- 3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.36,83,02,000/- (Rupees Thirty Six Crore Eighty Three Lakh and Two Thousand Only) being the State Share contribution of Grants-in-Aid to the Third and Fourth Installment Infrastructure Maintenance under National Rural Health Mission for the year 2018 2019.
