ORDER:

In the Government Order first read above, inter alia orders have been issued for the creation of 192 Staff Nurse posts in the time scale of pay of Rs.9,300-34,800+ GP 4,450 and other usual allowances for monitoring training activities under National Rural Health Mission at the rate of 6 Staff Nurses per district initially for a period of one year from the date of appointment. Further the Mission Director, National Rural Health Mission has been permitted to rationalize the 192 No. of posts of these Staff Nurse posts among 42 Health Unit Districts (HUDs) depending on the Number of Blocks / Primary Health Centres in each Health Unit District and also authorized to train these staff nurses in 3 spells of 15 days each to enable them to function effectively as training Staff Nurses. In the said Government Order, the Job functions of these training Staff Nurses were also issued.

2. The Mission Director, State Health Society in his letter second read above has stated that based on the G.O. two spells of training in two batches for a duration of 3 days were conducted to these Staff Nurses during November 2013 & January 2014. Further he has informed that the Director of Public Health and Preventive Medicine has conducted a meeting on 18.12.2013 with the representatives of Tamil Nadu Government Village Nurse Association and based on the deliberation he has sent a modified job functions. The Mission Director, State Health Society has therefore requested the Government to issue an amendment to the reference first read above including the following points:

- i. There will be no overlap of the functions of these mentor Staff Nurses with the existing functions of other Staff such as VHN/ANM, SHN and CHN.
- ii. Any other responsibilities that may arise from time to time.

3. The Government after careful consideration, has decided to accept the proposals of the Mission Director, State Health Society and the Director of Public Health and Preventive Medicine to include the following Job functions to the Training Staff Nurses in addition to the Job functions already prescribed in the Annexure to the Government Order first read above.

- i. There will be no overlap of the functions of these mentor Staff Nurses with the existing functions of other Staff such as VHN/ANM, SHN and CHN.
- ii. Any other responsibilities that may arise from time to time.

Accordingly the following Amendment is issued to the G.O(Ms.) No.99, Health and Family Welfare (EAP II-2) Department, dated: 02.05.2013.

AMENDMENT

The following entries shall be added after the existing entry (i) in the Annexure to the G.O(Ms.) No.99, Health and Family Welfare (EAP II-2) Department, dated: 02.05.2013 and they shall be read as (j) and (k) respectively:-

- (j) There will be no overlap of the functions of these mentor Staff Nurses with the existing functions of other Staff such as VHN / ANM , SHN and CHN.
- (k) Any other responsibilities that may arise from time to time.
