ORDER:

The High Level Monitoring Committee held on 26.9.2011 had approved for a sum of Rs.1.34 crores for construction of buildings for District Head Quarters Hospital, Pennagram.

- 2. In his letter first read above, the Director of Medical and Rural Health Services has forwarded the proposal to accord sanction for a sum of Rs.1.34 crores for the construction of Accident and Emergency Ward (Rs.68.30 Lakhs) and 12 bedded Children's Ward (Rs.65.70 Lakhs) for Harur Government Hospital
- 3. The Director of Medical and Rural Health Services has stated that as new buildings are under construction under NRHM funds at Government Headquarters Hospital, Pennagaram, the funds of Rs.1.34 crores earmarked to Government Headquarters Hospital, Pennagaram under 13th Finance Commission may be diverted to Government Hospital, Harur. The Project Director, Tamil Nadu Health Systems Project who was consulted has stated that the Chief Medical Officer, Government Hospital, Tiruppathur, Vellore District has reported that in view of growing strength of patients the available infrastructure in Government Hospital, Tiruppathur, Vellore District are insufficient and had requested additional CEmONC Centre and Accident and Emergency Ward separately.
- 4. During the Heads of Department Meeting held on 16.7.12 the Project Director, Tamil Nadu Health Systems Project requested the Government to issue orders for the construction of building to CEmONC Centre for Government Hospital, Tiruppathur, Vellore District at a cost of Rs.443.00 lakhs by diverting the 13th Finance Commission grant of Rs.1.34 crores approved by High Level Monitoring Committee for Government Hospital, Pennagram, Dharmapuri District to construct CEmONC Centre in Government Hospital, Tiruppathur, Vellore District. The Project Director, Tamil Nadu Health System Project stated that the remaining amount of Rs.309.00 lakhs will be met out from the NRHM funds.

- 5. The High Level Monitoring Committee in its meeting held on 10.8.2012 has approved the proposal for the construction of building to CEmONC Centre for Government Hospital, Tiruppathur, Vellore District at a cost of Rs.443.00 lakhs by diverting the amount of Rs.134.00 lakhs already approved by the committee towards Pennagram District Head Quarters Hospital and meeting out the balance amount of sum of Rs.309.00 lakhs from out of NRHM funds as it is essential to have CEmONC Centre building at Tiruppathur, Vellore District.
- 6. The Government have examined the request of the Project Director, Tamil Nadu Health Systems Project in the light of approval provided by the High Level Monitoring Committee and proposed to accord permission for construction of building for CEmONC Centre at Government Hospital, Thiruppathur, Vellore District at a cost of Rs.443.00 lakhs (Rupees four Crores and forty three lakhs only) by diverting the amount of Rs.134.00 lakhs towards Pennagram District Head Quarters Hospital as approved by the High Level Monitoring Committee and meeting out the balance amount of Rs.309.00 lakhs (Rupees three Crore and Nine Lakhs Only) from out of NRHM funds.
- 7. Accordingly, the Government accord administrative and financial sanction for a sum of Rs.134.00 lakhs (Rupees one Crore and thirty four lakhs only) for construction of building for CEmONC Centre at Government Hospital, Thiruppathur, Vellore District.
- 8. The expenditure sanctioned in para 7 above, shall be debited to the following head of account:-
 - "4210 Capital Outlay on Medical and Public Health 80 General 800. Other Expenditure Schemes in the Twelfth Five Year Plan II. State Plan. JC Improvement of Health Infrastructure by using 13th Finance Committee Grant 16 Major Works.

(DP Code 4210-80-800-JC -1600.)"

- 9. The Director of Medical and Rural Health Services, is authorized to incur the balance amount of Rs.309.00 lakhs from the NRHM fund.
- 10. Necessary funds will be provided in Revised Estimate/ Final Modified Appropriation 2013-2014. Pending provision of funds, the Director of Medical and Rural Health Services is authorized to draw and utilize the amount sanctioned in para 6 above. However, this expenditure will be brought to the notice of the legislature by specific inclusion in the Supplementary Estimate 2013-14. The Director of Medical and Rural Health Services is directed to including this item-of-expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2013-2014 and send the necessary draft explanatory notes for inclusion of expenditure in Supplementary Estimate, to the Government in Finance Department without fail.

11. This order issues with the concurrence of Finance Department vide its U.O.No.2542/H-II/2013, dated:8.4.2013 and ASL No.29, (Twenty nine).
