ORDER:

In Government order first read above, orders were issued for constitution of District / City Level Vigilance and Monitoring Committee (D/CLVMCs) for watching implementation Programmes of National Health Mission under the overall frame work of implementation as per the guidelines of Government of India.

2. In the letter second read above, the Government of India, Ministry of Health and Family Welfare, National Health Mission has stated that Ministry of Rural Development has constituted District Development Co-ordination and Monitoring Committee (DDCMC) known as "DISHA" committees in various Districts for coordinating and monitoring the implementation of various centrally sponsored schemes including the National Health Mission. Hence all the functions of District / City Level Vigilance and Monitoring Committee of National Health Mission have got subsumed in to "DISHA" committees.

4. The Government of India, Ministry of Health and Family Welfare, National Health Mission has also stated that to avoid duplication, it has been decided to discontinue the existing District / City Level Vigilance and Monitoring Committee (D/CLVMCs) under National Health Mission.

5. The Rural Development and Panchayat Raj Department has stated that the Director of Rural Development and Panchayat Raj has been directed to constitute 'DISHA Committee' under the Chairmanship of Member of Parliament's as per the

guidelines of Government of India and to take further action and also to issue necessary notification for forming the above said committee in all Districts.

6. In the circumstances stated above, the Government direct that the District / City Level Vigilance and Monitoring Committee (D/CLVMCs) constituted under National Health Mission in all the Districts / City vide the Government order first read above, be discontinued to avoid duplication.
