ORDER:

In letter read above, the Mission Director, National Health Mission has stated that the Tamil Nadu has been the Role Model for Various states in implementing a robust and efficient health care setup. The State is also known for introducing various pro people scheme and implementing them successfully. Following the tremendous success in reducing mortality and morbidity, such schemes have been later adopted by other states as well the centre. Use of Tamil Nadu Medical Service Corporation in Drug Procurement, CEmONC Centres, Cadaver Organ Transplant Programme, SNCU for few such schemes. Efficient and Effective Public Health System has reduced infectious diseases and now the predominant cause of mortality and morbidity is Non Communicable Diseases.

2. The Mission Director, National Health Mission has also stated that the State of Tamil Nadu is the seventh most populous and highly urbanized in the country with 14,257 km of National and State highways. In 2016, the State accounted for 17,311 deaths due to Road Traffic Injury (RTI) which is 12% higher when compared to 2015. In the country the State constitutes to a share of 15.9% injuries and 10.7% deaths (MoRTH, 2015). As per the Global Disease Burden report 2017, the Disability Adjusted Life Year's (DALY's) lost due to Injuries is 13.5 % (Unintentional injuries, Self harm and Interpersonal Violence and Transport Injuries). Road Traffic Accident has been an overwhelming Public health challenge of the era disproportionately killing and maiming many in the economically productive age group. It results in serious physical, mental and psycho-social impairment, bringing huge catastrophic expense to the family, crashing down its peace and security. Because of the increasing incidence of Accidents, Infarctions, Cerebro Vascular Accidents (Stroke), Accidental and Deliberate (Self Harm) Poisoning and Burns along with increased prevalence of those with residual morbidity due to these conditions, it is imperative to pay more and focused attention to these conditions. Hence there is need of a dedicated programme aimed at addressing these conditions at all (Primordial, Primary, Secondary, Tertiary and Quarternary) levels of health care. Hence Tamil Nadu Accident and Emergency Care Initiative (TAEI) has been conceptualised and created.

3. The Mission Director, National Health Mission has also stated that the Concept of ED is new in the Government hospitals and Tamil Nadu Emergency Care Initiative aims to establish one such in order to decongest the ER (prevent unnecessary overloading and delays in being seen by specialist). The following 3 Hospitals have been selected based on the case load handled in Accident & Emergency ward.

4. The Mission Director, National Health Mission has also stated that the State Planning Commission have recommended the Proposal "Tamil Nadu Accident and Emergency Care Initiative - Establishment of Emergency department in 3 Medical College Hospitals on Pilot basis" for funding under Tamil Nadu Innovation Initiatives (TANII) for Rs 854.00 lakhs with no additional staff cost / human resources. Also it has stated that no new Proposals for sanctioning of additional human resources will be entertained for this project. As per this proposal, Emergency Department will be established in 3 Medical College Hospitals on Pilot basis as mentioned below:

5. The Mission Director, National Health Mission has also stated that the Entire Cost is for Procurement and Installation of the Equipment and Procurement of the Consumables. There is no need for new buildings or Additional Human Resources for these services at ED department. Recurrent Costs, if any, shall be

met from the Chief Minister Comprehensive Health Insurance Schemes funds of the respected institutions.

- 6. The Mission Director, National Health Mission has requested to issue necessary orders in this regard.
- 7. The Government after careful examination have decided to accept the proposal of the Mission Director, National Health Mission and accordingly issue the following orders:
 - i. The Mission Director is permitted to implement "Tamil Nadu Accident and Emergency Care Initiative - Establishment of Emergency department in the following 3 Medical College Hospitals on Pilot basis" with funding under Tamil Nadu Innovation Initiatives (TANII) for Rs 854.00 lakh by procuring the Equipments and Consumables as below:

- iii. Necessary funds have been provided for a sum of Rs.244 lakh for the year 2019-20 in Budget Estimate 2019-20 at the rate of Rs.122 lakh per unit for 2 units in one Medical College Hospitals towards procurement of above equipments and consumables from State Planning Commission Tamil Nadu Innovation Initiatives funds.
- iv. The Mission Director, National Health Mission is permitted to procure the above equipment and consumables through Tamil Nadu Medical Service Corporation with approved specifications or from the Rate contract available with Tamil Nadu Medical Service Corporation.
- v. The Mission Director, National Health Mission is permitted to conduct a detailed study regarding the Utility and Cost study of this Pilot Project utilizing the in-house services of PG students of Medical College without additional expenditure.
- 8. The amount sanctioned in para 7 (ii) above shall be met from the State innovation fund and debited to the following head of account:
