ORDER:

In letter read above, the Mission Director, State Health Society has stated that the Tamil Nadu Accident and Emergency Care Initiative (TAEI), has been launched, in 76 designated Tamil Nadu Accident and Emergency Care Initiative centers aiming to strengthen the pre-hospital, in hospital and rehabilitation care. It encompasses the 6 pillars namely management of Stroke, Myocardial Infarction, Trauma (includes Road Traffic Accidents), Burns, Poison, Pediatric emergencies and other Life threatening conditions Tamil Nadu Accident and Emergency Care Initiative centres are being established uniformly across the State, such that any patient in emergency is treated by the right person, at the right place, within the golden hour for which adequate infrastructure, equipment, consumables, HR and training are being provided. In this regard, it is necessary to address the gaps in provision of emergency Lab test so that the early availability of Lab Results in ER is ensured. The State Planning Commission has recommended for Point of Care Testing (POCT) in 25 centers at a cost of Rs. 277.50 Lakhs for funding of innovative schemes under Tamil Nadu Innovations Initiative (TANII) (Round –II) for the year 2019-2020.

2. The Mission Director, State Health Society has also stated that the Point Of Care Testing (POCT) is a transportable, portable, handheld device to measure various analytes simultaneously in the same specimen by means of cartridge, membrane based system, strips etc. It largely minimizes the blood test turn-around time as the tests in ER. like ABG (For Emergencies), Troponin (For heart attack), Serum Electrolytes (for Emergencies), Complete Blood Counts (for Dengue), Kidney Function Testing (for Uremia), Liver Function Tests, PT INR (International Normalized Ratio), NT Pro BNP (N- Terminal Pro Hormone Brain Natriuretic Peptide), Urinalysis can be done during emergency in the bed side itself and results delivered for immediate commencement of treatment in ER.

3. The Mission Director, National Health Mission has therefore requested to issue necessary orders in this regard.

4. The Government after careful examination have decided to accept the proposal of the Mission Director, National Health Mission and issue the following orders:

- i. Sanction is accorded for an amount of Rs.277.50 Lakhs (Rupees Two crore seventy seven lakh and fifty thousand only) towards implementing the Point of Care Testing (POCT) facility.
- ii. The Mission Director, National Health Mission is permitted to implement the Point Of Care Testing (POCT) facility in 25 Tamil Nadu Accident and Emergency Care Initiative centers indicated in Annexure A at a cost of Rs.277.50 Lakhs approved under the Tamil Nadu Innovations Initiative (TANII) (Round-II) for the year 2018-2019.
- iii. The Mission Director, National Health Mission is permitted to procure the required Equipment and Consumables through Tamil Nadu Medical Services Corporation (TNMSC).
- iv. The Mission Director, National Health Mission is permitted to release the above funds allotted for POCT for the 25 Tamil Nadu Accident and Emergency Care Initiative centers to Tamil Nadu Medical Service Corporation (TNMSC).

5. The amount sanctioned in para 4 (i) above shall be met from the State innovation fund and debited to the following head of account:

"2210-Medical and Public Health – 01 Urban Health Services – Allopathy – 110 Hospital and Dispensaries – State's Expenditure - EQ Tamil Nadu Accident and Emergency Care initiative – Point of care testing (POCT) in Emergency Room in Medical College Hospitals under State Innovation Fund – 19 Machinery and Equipment – 01 Purchase"

The above expenditure shall be adjusted by deducting under the following head of account.

"2210-Medical and Public Health – 01 Urban Health Services – Allopathy – 902. Deduct Amount met from State Innovation Fund – State's Expenditure – JB. Deduct – Amount met from State Innovation Fund – 30. Inter – Account Transfers"
