ORDER:

In G.O(Ms).No.164, H&FW (EAPII-2) Department, dated 10.5.2012 order were issued for the construction of immunisation Ware House in 10 districts at cost of Rs.10 lakhs each at State Ware House at the Directorate at a cost of Rs.25 lakhs. A sum of Rs.125 lakhs was sanctioned in the said G.O for construction of the Ware Houses.

2. The Mission Director, State Health Society has now stated that the Director of Public Health and Preventive Medicine has requested to sanction the balance funds of Rs.20.00 lakhs from District Ware House approved funds as additional funds required for the construction of State Head Quarters Ware house at the total cost of Rs.45.00 lakhs. Request of the Director of Public Health and Preventive Medicine was placed in the 21st E.C of State Health Society and approved by the E.C. A sum of Rs.20.00 lakhs has been remitted to Government of Tamilnadu vide Chalan No.8500, dated 22.11.2012 of State Bank of India. Treasury Branch Thousand Light, Chennai.

3. The Mission Director has stated further that the civil works for the construction of Immunisation Ware House at the State Head Quarters at the cost of Rs.45.00 lakh have to be carried out by the PWD authorities. He has requested that the additional sum of Rs.20.00 lakhs may be sanction to PWD authorities for the execution of additional civil works for construction of Immunisation Ware House at State Head Quarters at the total cost of Rs.45.00 lakhs. (Rs.25.00 lakhs has already been sanctioned and Rs.20.00 lakhs has to be sanctioned. The Engineer in Chief and Chef Engineer (Buildings), Public Works Department, Chepauk, Chennai may be authorised to issue orders to the Executive Engineers of PWD divisions in the concerned district for drawing the funds through PAO/Treasury as the case may be, for the works in the respective district / division, under the following head of account

"4211 00 Capital out lay on FW 103 Maternity and Child
Health schemes stands between Central and State"

He has also requested to make necessary provisions in the RE/FMA 2012-13 by providing necessary DP Code under the Capital outlay "4211 00 103 16 civil works for 1909 RCHP Dept" The drawal of funds may also be allowed in this regard, pending receipt of RE/FMA 2012-13 as the required funds have been already remitted to Government.

4. The Government after careful consideration has decided to accept the proposal. They accordingly sanction an additional amount of Rs.20.00 lakhs (Rupees Twenty lakhs only) to the Chief Engineer (Buildings) PWD, Chennai-5, for the construction of State Headquarters Immunization ware house at DM&RHS compound at total cost of Rs.45 lakhs.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:

"4211 00 Capital Outlay on Family Welfare – 103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan –III Centrally sponsored – SA - National Component – Reproductive and Child Health Project – 16 Major works (DPC 4211 – 00-103-SA 1608)

8. This orders issues with the concurrence of the Finance Department vide its U.O No.77/Js(Dr.P.U)/Health-I/2013, dated 4.4.2013 .


